Initially, it was proposed by President John F. Kennedy, it overcame intense resistance from Southern Congressmen but then enacted under J. F. Kennedy's predecessor, President John F. Kennedy. During the successive periods, Legislature extended the Act to pass new federal legislation, like the Voting Rights Act of 1965, because the passage of the previous Act was not fulfilling the ordinary civilians' goals (1).

They had to pass it to enhance equality since the new Act mainly aimed to reduce black Americans' discrimination and voting rights. The 1964 Civil Rights act accelerated the demise of Racial Segregation. It provided Black People with a fair right of entry to cafes, travel, and other public amenities. It has helped African Americans, females, and some other disadvantaged groups wash away differences at their workplaces. The public determination to the Civil Rights Legislation and reduce discrimination has mobilized attempts to integrate schools. It has led to equal work opportunities since a committee was set to ensure a fair recruitment process. There existed some uncertainties as to whether the bill's rules extended to private industries. More or less, public platforms have sought to turn everything into private industry instead of just disassembling and giving a chance to the black Americans (9). These actions have been termed illegal.

#### Racial Discrimination between 2010-2020.

## LGBTQ.

They get discriminated against because of their sexual orientation, and as a result, they face depression and anxiety, which lead to violence or suicide. Same-sex relationships started long ago, but d did not accept it during the old days. The transgender, gays, bisexuals, lesbians, and people still face many difficulties up to date despite all the individuals' sexual orientations being accepted. Society still views them differently and tends to discriminate against them. The people who come from lower socioeconomic statuses suffer much more from the negative impacts of their life status than persons with a higher socioeconomic status. There exist inequalities in the United States due to socioeconomic status in health care qualities and other opportunities.
