An Analysis of The Impact of Abundant Circulation of Porn VCD

Abstract

The research was entitled: Analysis to the Impact of Abundant Circulation of Porn VCD (A descriptive Study among Adolescents in Sub-province of Banyumas). This research was backgrounded on the existing problem that circulation of porn VCD could not be blocked. This condition was supported by the progress of communication technologies, such as internet and sophisticated cellular phones. Method used in this research was a *descriptive qualitative* with *purposive sampling technique*. The informants consisted of children that became victims of sexual crimes, adolescents who committed sexual crimes, distributors, tradesmen of porn VCDs, Binamitra NGO and Head of Crimes Division of Polres Banyumas, Head of Sub-section Prosecuting Attorney and her staffs. Research result indicates that (1) looking on porn VCD became a choice that was refreshing; (2) many sexual crimes had been conducted by mature damage of the nation (3) the circulation of porn VCD gave contribution to morality damage of the nation (4) inconsistence of the regulation executions were caused by business factors (5) raid by the police was not intensive and (6) such crime sanctions were still on light conditions, therefore the sexual crime actors do not discourage as well.

Introduction

The circulation of porn VCD, nowadays, cannot be blocked again. Since mass communications technologies are growing, porn pictures are available in many websites. At the same time, cellular phones can alternatively be used to see the pictures by transferring it using some Bluetooth device. Porno VCDs can be easily accessed by everyone for all ages in everywhere and every time. If it really happens, the effect will be very bad for human psychology. Similar to narcotic case, it is very hard to cure, because it needs synergic cooperation between internal and external factors from the people.

Porn VCD is a VCD which performs porn movie. This kind of movie can be divided into two models: *double x* and *triple x*. The *double x* model is a movie which performs women's breast which are covered by lest fabric. The film itself may contain story or not. If the vagina or penis is not displayed when doing coitus, it is called semi-movie. The

movie may be interesting because it has story to tell. Audiences are sometimes challenged by the plot. Meanwhile, the *triple x* model is a porn movie which performs vagina, penis and women's breast vulgarly—doing coitus between different gender (now often with the same gender)—without any stories.

The problem is that porn movies arouse certain senses which are very private. Those senses include kissing sound, fantasy of sexual imagination, or perhaps desire to come into it—by trying to do the movement displayed in the porn VCD. The unwanted effects are changes at cognitive, attitude, or behaviour level.

Based on the above understanding, the effects of the abundant circulated VCD—especially among adolescents - are interesting to analyse. As we know that teen is controlled in the process of psychological growth.—which is very connected with adolescents' future. How do the components of society respond to the abundant? Do they let it

go—pretending there is nothing happened in their society? Which development agent should take responsibility? Is there any possibility to get the exact model and effective strategy to anticipate or to minimize the effects?

The circulation of porn movie is within the domain of law as this issue can be considered as crime. Law and order to each people is very important. It is written in the formula of criminal action. Problem concerning with porn movie is that the effect is very dangerous for the development of moral values within society. That is why the issue of pornography is included in the criminal dimension. It is arranged in KUHP Article 40 Regulation No. 8 year 1992, which says:

- a. Anyone who intentionally circulates, exports, or exhibits film and/or advertised film which is refused by The Censorship foundation (LSF) according to article 33 point (6); or
- b. Anyone who intentionally circulates, exports, or exhibits film or displays some scenes or certain sound which is refused by the Censorship foundation (LSF), according to article 33 point (6).
- c. Anyone who intentionally circulates, exports, or exhibits film without censoring, according to article 33 point (1).

In its application, every criminal action in movie industry especially about the circulation of porn VCD, the Public Prosecutor claims defendant with Article 40, Regulation No. 8/1992 and article 282 of KUHP.

This is the article 282 of KUHP:

a. Anyone who publishes, looks on, and pastes up frankly an article which he knows, or a picture or some goods which he knows it collides with good manners, as well as makes, brings in, sends directly, bring out or provides an article, picture,

- or such goods to be published, watched, or pasted on, therefore people will watch it; or frankly publishes an article, or frankly is asked or shows if the article, picture, or goods are accessible, will be imprisoned as long as 1 year and 4 months or fined as much as Rp. 45.000,00
- b. Anyone who publishes, looks on, and pastes up frankly an article which he knows, or a picture or some goods which he knows it collides with good manners, as well as makes, brings in, sends directly, bring out or provides an article, picture, or such goods to be published, watched, or pasted on therefore people will watch it, or publishes any article, offers by himself or shows if the article, picture, or goods are accessible, will be imprisoned as long as 9 months or fined as much as Rp. 45.000,00 if he has a reason to estimate that bringing such article, picture, or goods collides with the feeling of good manner.
- c. If committing such criminal actions in the first article as occupation or habit by the accused, will be imprisoned as long as 2 years and 8 moths or fined as much as Rp. 75.000,00 (KUHP articles 37, 137, 144, 161, 208, 283, bis, 310, 321, 483, s, 533).

Porn VCD can be categorised as movie. Regulation No.7/1994 about LSF article 18 point 4 says that a movie which deviates from social and cultural values is a movie which damages and does not conform to the norms of public manners in Indonesia; and can harm and damage morals and characters of society. Whereas, according to Regulation No. 8/1992, article 3 about movie industry, says that a movie which cannot develop people's character and personality, cannot raise human value and dignity, cannot maintain moral values, does not perform a good entertainment which conforms to the social life norms. According

to point 5, porn VCD is a movie which violates public order as it focuses only on story or scene about sex. Porn movie according to article 19 includes:

- 1. Scenes that show naked or give sense of naked condition to man and woman, either it is visible from front, side, or behind.
- 2. Close up of vital organs, thigh, breast or buttock with or without its cover.
- 3. Kissing scene that arouses stimulation either it is done with full of passion by the two different gender or same gender.
- 4. Scene, movement or voice of coitus or anything that gives sense of human coitus in action weather visible or invisible.
- 5. Movement or action of masturbation, lesbian, homo, or oral sex.
- 6. Scenes which can arouse unethical sense.

In fact, porn VCD is wanted and looked for by many people. It has subjectively meaning and utility for each individual and becomes a final value when other values become unnecessary. Including a consideration to consume porn VCD no matter whether it is right or wrong—however, everyone absolutely has another aim which is his privacy.

VCD as a kind of medium can raise audience consciousness. Its quality is to active audiences and who intentionally use such media to reach their certain aims. Therefore, it should be looked up and considered that porn VCD is not for personal utility, but it is something that is used to satisfy a need or a very deep desire.

In light of the context above, the purpose of this study includes to identify the influencing factors of the abundant circulation of porn VCD in sub province of Banyumas; to identify which parties are competent to handle the problem of the circulation of porn VCD in sub province of Banyumas; and to know the effects of the abundant of circulation of

porn VCD toward adolescents. The rationales for this study are to contribute ideas to related parties, such as government institution, non-governmental organization, and also individual referring to the impact caused by the abundant circulation of porn VCD especially among adolescents; and to give contribution of thought to adolescents in order that they can anticipate and control themselves positively referring to the abundant circulation of porn VCD.

Research Method

Research location

This research was located in Sub province of Banyumas—Central Java. The region is a prosperous town. There is a state university, University of Jenderal Soedirman and also some private universities.

Research Subject

Subjects of the research were adolescents at the age of 16 to 23 years old who watched porn VCD which could be revealed from casual renters, rental VCD shop owners, people, VCD pirates, or their friends as well as people who were close related to the research subjects. It also took respondents who had committed the "sexual crime" – that were indicated as regular porn VCD reviewers. Some related institutions were also included to be the subjects such as: investigation result from Police Regional Headquarter of Banyumas, and the Attorney General of Purwokerto—that followed up the process from the police and then bring it into the court.

Research Method

The research method employed was qualitative research method which produced descriptive data such as written statements from the

observed subjects and their behaviours. The characteristic of the research focused on creativity and spirit of the researcher to dig out the data as deep as possible to get what

Data Collecting Technique

Research data was collected using in-depth interview which was informal and open minded, by giving some questions directly to the informants as well as paying attention during the observation process that helped the research. What the research wanted to stress on was to discover some characteristics and elements of the situation referring to the problem or issue. Besides, I also used some literatures, documents, books, and articles as additional references.

Informant Electing Technique

The informants were elected using purposive sampling technique; each subject was divided into groups according to certain features and characteristics which were supposed to have correlation with the previous decided criteria (*Marzuki*, 1995:87).

Data Analysis Technique

Data Analysis technique used was qualitative with interactive analysis model. The model consisted of 3 components. They were data reduction, data presentation, and conclusion drawing (verifications) done interactively by collecting the data as a cycle (Miles and Huberman, 1992). In concrete, the model used adequate casual interview, but still focused on the problems.

Data Validity

The research used triangulation with source and method for its validity. Triangulation source is

how to prevent any refracted research and to check information from different sources and informants (Bodgan & Taylor, 1992: 8). On the other hand, Moeloeng (1990: 178) triangulation is a technique to determine the data validity which utilizes another thing out of the data to check or to compare with thedata itself. Whereas, triangulation method according to Patton (Moleong, 1990: 178), there are two strategies: (1) checking the degree of belief of the research result by using data collecting techniques; and (2) checking to several data sources by using the same method.

Presentation and Interpretation of Data

Informant Characteristic

Informants involved in the research include: (i) adolescents group, (ii) victim group of sexual crime done by irresponsible people, (ii) sexual crime perpetrators—done to adults and children, (iv) porn VCD renters and circulators group, (v) Head of Criminal Action Division Polres of Banyumas, and (vi) head of subdivision—Prosecuting Attorney in Office of the counsel for the prosecution of Purwokerto.

1. Teenagers Group

Nia (19)

A student of Faculty of Economics, the University of Jenderal Sudirman, said that:

Isaw a porn picture for the first time from a VCD that was placed inside my father's cupboard. It was put under piles of clothes. I was just 16 years old. My house was so quiet. So I played the movie. I was disgusted and trembling, but I kept watching till the end. At school, I told the experience to my best friend. She was so excited. Several days latter accidentally when I was in a public internet service I watched the same movie. I became get used to watching it. There was an imagination passing through my mind whenever I watch porn movies. I can say

that if I am asked more detail about the effect of watching the movie is that I become an easy going person. So I have some references how to act with my boyfriend. But I ensure you that I can keep myself to avoid doing sexual intercourse.

Yustin (21)

A student of Law Faculty, the University of JenderaSudirman, gave his comment as follows:

Once I watched porn VCD with my friends at their boarding house. We discussed the movie whilst watching. We wanted to know more. Since then, we often search porn sites via public internet services. One day I imagined the scenes I had watched. There was a time when I was with my boyfriend, he unconsciously touched my sensitive organs. Fortunately, I realized that it was not good for me. We both realized that it was not the time. If asked about the effect... it is obviously dangerous. If we lost our faith we'd be drifted away to do sex. Actually, the more we have references, the more we are bold to do such things like kissing and hugging.

Nino (20)

A student of Faculty of Social and Political Sciences, the University of Jenderal Sudirman, said that:

I'm the youngest of three siblings. I often feel lonely at home. My parents are busy with their works. Meanwhile, my brothers are attending colleges outside the town. I have got experiences of watching porn video since I was in 11th grade of high school. For now, I often receive it through Bluetooth device from my friends' cellular phone. I watch it before I go to bed. Sometimes, when I sleep I have wet dreams. I don't have any girlfriend. I've been searching for a beautiful and a good shaped girlfriend who loves me. When I get stressed I go to public internet service to browse some porn sites. I can stand long enjoying the sites at the place.

Sonny (25)

He is a civil engineering student who came from Jakarta. His appearance was calm and his attitude seemed mature. Question from the researcher was not directly answered. Instead, he smiled. With some extra effort to make the situation conducive, the research finally got an answer. He slowly put out his six porn VCDs and said:

I often play the VCDs. I have done it since 12th grade of high school. Sometimes with my girlfriends if they wanted. I did it just for fun. My family have no idea about that. I cannot get away from such enjoyment until now. Sometimes I think about quitting from it, but again I'll look for it.

Budiono (19)

Living in Sumbang Village—sub district of Sumbang—sub province of Banyumas. He gave his comment as follows:

I am jobless—can't continue my study. I am a graduate of electrical vocational school. I think watching porn VCD is common. It's easy to get it. Don't be hypocrite; I think many boys and girls here have watched it. Sometimes I watch alone, sometimes with my friends. We sometimes watch once a week. It's just for fun as we have nothing else to do. I did it with my girl friend twice. It didn't make me addicted. We loved each other and it wasn't a force. We did it in a recreation place. Now we've broken up.

Adit (17)

A vocational school student of 12th grade, from Karanglewas said:

I'm the eldest of three siblings. I drive motorcycle to go anywhere. My dad is a businessman and my mom is a house-wife. My dad is very busy that he doesn't stay very often at home. Instead, my mom really cares. She even spoils me. Watching porn VCD is a regular for me (at least once in a week), either from VCD or internet sites. I often daydream and want to do it. I had sex twice with a prostitute, but not anymore. Sometimes I want to have a girl friend who wants to have sex, but I'm always scared to tell her. Now I'm preparing myself for the school final examination. I try to concentrate, but sometimes get bothered in my mind.

Based on the information from the six respondents above it is concluded that: (1) When adolescents watch porn movies, there is a tendency

that they want to imitate the scenes; (2) Parents do not realize if the sexual growth of their children has gone far. Parents consider that their children are calm and have good attitudes. Informants say that parents will be angry if their children's conditions are poor.

It is better for parents not to get angry easily with their children. Further, parents must give more attention and affection to their children. In order to strengthen their faith and increase self-control, religious activities and family discussion must be intensified. Willingness to do sex is natural (Ballaz in Lesmana, 1995, p.148-149). Sex case is as hard as narcotic case—which its solution is not easy and needs long time to deal with the situation. On the other hand, parents should control their children's activities carefully.

On May 2007, I was shocked by a story of two parents who told that their 9th degree of high school daughter was pregnant for four months. The parents commented:

I was sad and really ashamed.... I was very angry. We always gave things she wanted. She always watches and cries whenever we are quarrelling. One day, I found her drinking mosquito's killing liquid, then I run to your place to ask for your advice, madam...".

I then asked for permission to see their daughter. Through an in-depth interview technique which was casual but focused, I tried to discover whether she often watched porn VCD with her boy friend. As predicted before, the daughter told me that she likes to watch porn VCD. She gave her answer as follows:

At least once in a week then we imitate the movements displayed in the movie. Sometimes we did it either in my house or his house. My boy friend is a high school student at 11th grade. We loved each other. There has been some advice to my parents to marry me with my boy friend. That is the best solution in order that the baby will have a father. Afterward, we think of the possibility to move to private school or to take package C (educational) program. We will have a child at our young ages.

There are several aspects experienced by the teenagers when watching pornographic film, such as seduction, happiness, curiosity, and refreshing the minds. The implication of watching porn VCD does not depend on the age diversity. If the audience cannot control their feeling, it is likely that they will practice what they have seen. The lightest impacts that the audiences might do are the practices of hugging, kissing, and petting; whereas the serious impact that may happen is a sexual intercourse. As a result, pregnancy before married occurs as they are not ready to be parents financially as well as psychologically.

Above all, the psychological development of teenagers is usually unstable as they are in a transitional period. They will face new roles that are complicated, such as physical changing (sexual libido); social roles (from childhood into adulthood); conflict with parents; and searching of self identity. This condition often triggers them to find alternative solutions of their problems.

Sarlito (1998:115), in regard to sexual experience of teenagers from mass media, VCD, and films, states that education is urgently needed to prevent the miss conduct of teenagers from the negative impacts. The findings of this research also reveal that respondents have never had any sufficient sex education informally as well as formally. Further, teenagers rarely receive sexual education from their parents. Sex education may help preventing the bad effects of pornography. In Indonesia, most parents consider sex education as a taboo issue to discuss with their children. This condition can be seen as a problem in giving correct information as sex education relates to norms, religious values, and also good or bad moral in society. Therefore, sex education has a wide scope. Parents normally communicate with their children on certain topics such as career, study, health, and their relationships with other family members or

relatives. On the other hand, respondents think that problems relate to teenagers are more convenient to share with their peers. The fast development of technology may lead to the freedom of teenagers to watch pornographic films that will influence their sex information. Consequently, sexual values can be regarded as a permissive attitude.

It is quite often that unmarried female teenagers who are pregnant would be asked by their parents to abort the baby. In some cases, parents sometimes ask the children to get married soon. In this case, there is a conflict between children, parents, and other family members. Abortion for teenager may cause death if it is not handled by competence person professionally. Meanwhile, psychologically, children and parents will receive moral sanction as it is considered a sin. In relation to the abortion, Requena emphasizes that the use of contraception in society can become a problem. People do not have enough information about contraception and teenagers are shy to look for that information. When pregnancy before married happens, marriage would seem to be the best solution. Though dilemmatic, this will be the most convenient for many people to solve the problem.

2. The Victims Group of Sexual Crime Done by Irresponsible People

The data was obtained from the Head of Women Study Center—Research Institute of UNSOED (June 2007). Two respondents were located in Karangrau village—Sokaraja sub district—sub province of Banyumas, and the other two respondents were located in Rancamaya Village—Cilongok Sub district—Sub province of Banyumas. The interviews were conducted in different places and times. Then, with persuasive and language technique which is accepted by both child and her mother, the researcher got 4 girls. They were:

Ira (10), Widi (11), Nita (9), Yuni (12). With a casual dialog but focused on the matter, the researcher concludes that they experienced a serious psychologically trauma after the rape. They needed parental guidance especially from their mothers including some strict control. A good therapy that a psychologist had advised, had to be carried out. After that the researcher did some verification to their mothers and it was obtained some states that said:

Please madam... we are so sad. We have nothing to do about this tragedy; we are too ashamed to report to the Police, because I think it will be useless. We want the doer to receive a hard punishment, but after we arrived at kelurahan—the result was tranquility because the doers just promised not to do the same again some day. At last, we went home with disappointment.

Such crime should have been reported to the Police, until the doers are carried to the court in order that they deserve punishment. If the victim is not proactive to deal with this, there will be no serious handling. Finally, there will be more and more dangerous crimes.

3. Sexual Crime Actors—done to Adults and Children. The Two Respondents Below are Fictive Names.

Mario (41)

He is a labour in a garlic shop. He comes from Ajibarang. His wife was a labour in Saudi Arabia. When asked whether he often watched porn movie, he said:

I often rent from a renter who comes once a week. Sometimes I rent two or three pieces of VCDs. I often have sex with prostitutes or friends who also want to have sex. I once had sex with my 10th years old niece. Lucky me, she didn't tell her parents because I gave some money and school equipments. She didn't feel hurt. At the time, I liked that she was virgin, but poor her. I did it at home when the house was empty. The benefit I get from watching porn movie is that I get much knowledge of how to have sex with various styles.

Sarmini (38)

She is an entrepreneur (owner of small shop). The wife of a labour who works in noodle factory, often returns home at night. She has a pretty face and was fairly coquettish. From a trusted source's report, it is said that she had a special relationship with a married civil servant. She confessed that she often watched porn VCDs with her boyfriend in hotels/inns. "By watching those VCDs, we can have sex with various styles. We really enjoy it. We get used to do it because watching those VCDs have increased our passion."

The statement of two respondents above gained its evidence when I confirmed with related persons. The child who was named Vita (9), 3 year of elementary school, said, "I often receive some money from uncle Mario. I use the money to buy a school bag, shoes, and snack". Meanwhile the boy friend of Sarmini named as Darno—a civil servant—admitted that their relationship had been lasting for nearly three years. They got along each other with their families.

In spite the fact that that porn VCDs give knowledge about sex, they have initiated irresponsible sexual crimes. It means that the victims could be underage children. It may also lead to an affair that endangers someone's marriage. Sex criminal done by parents to their children actually has a deeper psychological effect and traumatic experience such as apprehension in a long term for the children; lack of self confidence and depression. A research conducted by Sarwono in 1985 in four cities, namely Purworejo, Banjarnegara, Pontianak, and Jakarta, found that sex criminals are paedophiles. This means that they do not have any compensation in channelling their desires. Girls normally become victims that cause a traumatic feeling as they are no longer virgin. They reserve to

make a relationship with men. Two respondents (Mario and Sarmini couple) seem to practice free sex that makes them vulnerable to sexual disease as they do not use any contraception. Person who get sexual diseases need more time and intensive to cure. It is possible that person who does not care about sexual disease may become serious. One of hazardous sexual disease is AIDS (acquired Immune Deficiency Syndrome). This disease is caused by virus called HIV (Human Immune Deficiency Virus) that causes the body resistance to immune of some virus is reducing drastically. Gradually, the HIV patients die because of lack of immune. People can be contaminated by HIV via needles, saliva, blood transfusion, and also sexual intercourse. The amount of HIV patients in Indonesia tends to increase. Even new born baby has a potential to become HIV carrier that is taken from the mother during pregnancy.

Thus, pornographic VCD is a tempting business that happens for a long time. It cannot be denied that the production of this porn VCD has a huge production with a wide market and very fast money circulation. It seems that people do not pay attention to this industry cored by a black box. It means that there is a mafia system that not everybody can understand the circulation of the product. Surprisingly, many people enjoy the pornographic VCD so this condition becomes very complex. Why the producers, distributors, sellers, and other parties related to this commodity cannot be stopped? Police control towards the distributions of pornographic VCD would not be effective because the mafia still continues the business. People often being sceptical as they often see as if there is an 'affair' between the distributors and other persons who should be in charge of preventing the spread of pornographic VCD. The sellers know when they have to hide and to sell pornographic VCD to the consumers, so that

they have already got information about any strategies that the police are going to conduct.

Observation and Interview with VCD Sellers/Renters and Circulator

The data collection was done from August 5th to 15th, 2007. In conducting the research, I was assisted by two college students. They had been prepared with some knowledge. They were asked to perform their task carefully in order that the sellers would admit that they sell porn VCDs.

The sellers in the town square and the store complex at Kebon Dalam, said that "usually we had that VCD. You can buy it, but I have no such VCD with me right now—we just won't take any risk. The price is Rp. 20.000,- per piece. It is true that we benefit a lot by selling this kind of VCD. It is easily got it in Glodok—Jakarta.

In doing verification to Binamitra (Police Resort of Banyumas—who was in charge to give some illumination to society), one of the office there said that from August until early of September 2007, the Police of central Java Province would conduct a raid in sub province of Banyumas. In fact, after August 20th until November 2007 all of VCD stores in regular places for selling those VCDs were closed by the owners. All street vendors who sold VCDs were also closed. Rentals that sold pirated VCDs—which were also indicated to sell porn VCD—still operated but they only sold and rented original VCDs. The same case also happened to some software and game rental shop around Unsoed. They did not rent out softwares, but only game CDs.

For that condition, I was ensured that after November 2007, the circulation of porn VCD would be continued. Those activities were closed down to show some respect to Ramadhan month. And most of elements within society agreed with that idea.

Research Conducted in Head of Crimes Division of Polres

Interview with Mr. Zaenal—Head of Crimes Division.

"Data obtained from the Head of Crimes Division indicates that there were about 10 cases per year from 2004. The most prominent case was when a father from Sub district of Rawalo—sub province of Banyumas, who raped his own daughter at the age of 12. The case was given to The Attorney General of Purwokerto".

"Cases which are begun from Police investigations are fairly good at encoding for processing. But, it is true that some cases go to the Attorney General, but some do not. If you ask about some data from the circulators or the duplicators—sorry, no data entry. At least a data about a man, Supriadi was caught of keeping 100 pieces of porn VCD is available. We have given the case to The Attorney General. I am sorry for not telling you the other cases, because it seems to be done by our people with a reason of their daily needs".

For the raid problem, there are 3 models:

- 1. Pre—endive: giving an illumination/socialization. It is conducted by Binamitra Polres of Banyumas.
- 2. Preventive—it is to prevent. For example the policemen guard around the location of sale. In order to prevent circulation of Porn VCD.
- 3. Curative/ repressive—acting strictly to the circulators and the sellers.

Dwi Budianto admitted that "Polres of Banyumas seldom do strict actions to the porn VCD sellers and tenants, because the police knew that they got the VCD easily in Glodog (Jakarta). Why the Police

does not give a strict action to the big croupiers? At last, what happens in Polres is what you see madam.."

Results of the research from the Police—were just a few, because the bureaucracy was rigid and the interview was not as the researcher hoped. However, it is common that a research in the Police will face many obstacles.

Research conducted to Mrs. Nila Aldriani—head of subdivision—Prosecuting Attorney in Kajari Purwokerto

When the research proposed his aim to get some data while giving a research proposal, spontaneously she said that:

"Your research is right; I am irritated and infuriated with the circulation of porn VCD. We just actually wait the time to bring the investigation from the Police to the Court. The most important thing is people's participation to anticipate this phenomenon which is very dangerous. The effect is massive, such as husbands want to do different styles as displayed on the porn movie. It causes also sexual crimes which are done by both adults and teenagers (Junior High school age). Some cases that have been received are (1) in sub district of Rawalo—sub province of Banyumas—in 2005. a father raped his own daughter while his wife knew about that. According to the judge, he should be punished for 12 years in prison—referring to Regulation of the Children Protection—not KUHP. If criminal action is done to children, the punishment will be 16 years in prison. The purpose is to protect children from any moral crime. Whereas, if it is done to adults, the maximal punishment will be 1 year and 4 months.

In a separated location she said that:

"Then, for the case of porn VCD circulator—which we received, was on October, 2004. a man named as Tri Supriadi was arrested. He was accused for circulating, renting, displaying and providing porn pictures/goods to audiences. He actually would

get the article 282 of KUHP—with it could be 9 months in prison. But after the furtherinvestigation, it's found that his boss was a civil servant who got along very well in the environment Attorney General. But the case was closed—not to be brought to the court".

What was said by Mrs. Nila was right. The same idea was also said by Ibi Sifa (Mrs Nilas's staff), "the Attorney General is just to follow up the Police investigation. And, the two previous cases (cases of a father from sub district of Rawalo and Tri Supriadi) had been gone through the Police investigation. What becomes the most important is actually the regulation should be strict. Light or hard the punishment is that we are not the people who create the regulation. KUHP is just a common, and the sanction is light. If it is done to children we will use the regulation of Children protection. If the victims are teenagers or adults, we will use KUHP with light sanction. It is clearly unfair; it does not make the criminal actors undaunted. In fact, the rape cases are getting more and more each day.

Based on the phenomenon, such deviations and crimes still rule over. In addition, problems in the judicial affairs are also not clear. Money can control either hard or light the crime punishment will be. Paying close attention to the criminal cases accursed in Indonesia, the judgments are not strict. Right or hard the punishment becomes unclear. A hard case sometimes gets a light punishment or even it is released by the judge; whereas, a light case sometimes gets a hard punishment. From the phenomenon, it is common that such deviations and crimes still rule over the society. Moreover, the cases in the Judicial Affairs level are not clear. Money can manage how to make the punishment either light or hard.

Conclusion

The circulation of porn VCD which is uncontrolled from time to time causes many effects to all human existences—unrewarding to ages. The research concludes that:

- 1. The circulation of porn VCD causes sexual crimes.
- 2. The circulation of porn VCD causes exploitation of sex to children and adolescents.
- 3. The circulation of porn VCD causes disharmony in a family because of an affair.
- 4. The circulation of porn VCD causes many prostitutions
- 5. The circulation of porn VCD causes adolescents to do premarital sex.
- 6. The circulation of porn VCD causes adolescents to be addicted to watch again and their concentrations to school become distracted.

The condition of the circulation of porn VCD which is easily accessible actually has a massive contribution to destroy people morality. Therefore, some advices from the researcher are:

- Regulation—to the sexual crimes should be reviewed, in order that the actors get deserved punishments.
- 2. Criminal sanction in KUHP—should become harder, in order that the actors are undaunted.
- 3. The Police raid of the circulation of porn VCD should be more often and more strictly performed.
- 4. People should voluntarily take part to observe the process of the circulation of porn VCD.
- 5. Parents should control their children concerning with the easiness to access porn movies.

The Local Government should perform concrete actions to deal with the effects of the circulation of porn VCD.
